7.6.2 V Bartlett and PK Harris knew of the Crime including **Fraud** of more than R100,000-00 before the Liquidation of the Company and long before this bank Sequestrated me.

8. This bank illegally (with no legal right) over-charged several hundred thousand Rand on a home bond.

8.1 This bank then proceeded to charge interest on these illegal over-charges.

8.2 This bank then proceeded to re-possess our home (my wife and I) and to sell our home on auction.

8.3 At the Enquiry which I was able to hold, Praise the GOOD Lord, I was able to **prove the Fraud**.

8.3.1 This bank's Claim was rejected by the Honourable Magistrate. This bank then (after I laid a charge of **Fraud** with the **Police**, even against the Directors of this bank) removed the illegal over-charges and the illegal interest from the bond a/c. It was over R200,000-00 plus interest that was removed.

8.3.1.1 The Honourable Magistrate went so far as to call on the Master of the High Court to Investigate, with a view to Criminal Prosecutions.

8.3.1.1.1 I can supply the **proof** to the Competition Commission of what I write. I can supply the bond a/c with the over-charges and I can supply the bond a/c with the over-charges removed after I laid charges with the **Police**.

8.4 The trouble is that the damage was done. Our home was taken from us in this illegal way.
