MS SAMIKSHA: So ja, like I said Dryver Foods would like to lay a complaint against Uber East and Mr D regarding the dominant position in the market.

CHAIRPERSON: I think we have now lost you. I think we have lost our participant. I think the panel is going to reschedule Dryver Foods, because I think it would also help if Mr Reddy himself appears before us rather than just have
10 a statement read out, so we will engage with Dryver Foods this afternoon and find an available slot for them to come and appear again, so with that we are going to close the morning session. Just to remind you, we will resume at 14:00 with Uber East and after Uber East we have got Quench and that completes our program for today. So we will see everyone at 14:00.
